Confirm that remote testing fits you

- ☐ I can complete the booked examination without a break.
- ☐ I can test without scratch paper or a physical calculator.
- ☐ I can stay in one room, on one computer, and in camera view for the full session.
- ☐ I can follow proctor directions about my hands, eyes, face, desk, screen, and room.

If any item is not realistic, compare test-center availability before booking or before the current change deadline.

Compatibility, identification, room, and launch

Run every compatibility check on the exact computer

- ☐ The PSI audio and video check passes.
- ☐ The PSI webcam check passes with the camera I will use.
- ☐ The PSI system check passes on the same computer, connection, and setup.
- ☐ Power and internet are stable enough for the full appointment.

Identification

- ☐ I have 1 accepted ID with the exact scheduled name.
- ☐ The ID has my signature and photo and is valid and unexpired.
- ☐ My document appears in the bulletin's accepted list for remote testing.
- ☐ I am not relying on a US military ID, which the current bulletin excludes for remote testing.

Accepted examples listed for remote use include a state driver's license or ID, temporary state driver's license or ID, US passport, alien registration card, foreign passport, and foreign government ID. The current bulletin controls the exact document.

Room and desk

- ☐ The space is private, quiet, adequately lit, and available for the full examination.
- ☐ The webcam is placed for the proctor's required view.
- ☐ The desk, nearby surfaces, walls, floor area, and camera view are cleared as directed.
- ☐ No reference material, notes, paper, writing tools, phone, watch, earbuds, camera, or recording device is accessible.
- ☐ No food, drink, tobacco product, or other prohibited item is present.
- ☐ My clothing and headwear comply with PSI's current security rules and any applicable religious-apparel allowance.

Launch

- ☐ I will open the appointment early enough to complete the required launch steps.
- ☐ I know that failing to start within 15 minutes after the booked time forfeits the fee or eligibility under the bulletin.
- ☐ I will follow the identity, environment, and proctor checks instead of changing rooms or computers.

During the remote examination

Camera and conduct

- ☐ I will remain in the camera's line of sight.
- ☐ I will keep hands on the desktop when directed.
- ☐ I will keep eyes on the computer screen when directed.
- ☐ I will avoid fidgeting and keep my hands away from my face when directed.
- ☐ I will avoid covering my mouth and will not talk, whisper, or mouth words.
- ☐ I will not read questions aloud, capture content, communicate, browse, or use an unapproved program or device.
- ☐ I will not change computers or spaces during the examination.

No-break and no-aid rules

- ☐ I understand that remote breaks are not allowed.
- ☐ I will not use scratch paper.
- ☐ I will not use a physical calculator.

If a problem occurs

- ☐ I will follow the proctor's directions and use the official support route.
- ☐ I will record the time, instruction, and case or contact detail without recording examination content.
- ☐ I will not solve a technical problem by switching computers, changing rooms, using a phone, or opening another program unless PSI expressly directs it.
